*pastor employment contract* May 14 2024 employment and duties hope city house of prayer hereby employs and hires pastor williams as its pastor and pastor williams hereby accepts and agrees to such employment the pastor s duties and responsibilities under this agreement are as follows

**contract for pastoral ministry** Apr 13 2024 you as the contract pastor will preach and teach the word of god each sunday and special days of the church year keep regular office hours on specified day s each week along with the opportunity for visitation preside at worship and administer the sacraments according to the practice and teaching of the lutheran church

*pastoral contract missionary chapel and seminary* Mar 12 2024 the pastor is being initially hired for hours per week for the performance of pastoral duties and responsibilities it is the hope of all parties for the pastor s hours to increase as the budget allows work hours include sermon preparation and sunday worship
