Pregnancy and the Pharmaceutical Industry 2023-10-09 the incidence of allergic diseases is increasing possibly due to a reduced intensity and diversity of microbial stimulation more knowledge is needed on the immunological mechanisms underlying the eczema preventive effect of pre and postnatal probiotic supplementation the pregnancy period seems to be of essential importance since both epidemiological and experimental animal studies show the importance of microbial exposure during gestation on allergy prevention we have performed a study where the probiotic lactic acid producing bacteria lactobacillus reuteri was supplemented to pregnant women at risk of having an allergic infant the pregnant mothers received the study product from gestational week 36 until delivery and the infants then continued with the same product until one year of age the probiotic as compared with placebo supplemented infants had less ige associated eczema at two years of age in order to investigate how the supplementation affected the immune system peripheral blood was collected and immune cells were stimulated with common allergens and tlr ligands the probiotic treated group responded with a more regulated response to allergens and tlr2 ligands in comparison to the placebo supplemented group we also investigated how the probiotic supplementation affected the epigenetic methylation pattern in circulating t helper cells during infancy observing the most pronounced effects at birth in a follow up study supplementation was started earlier to possibly gain a stronger allergy preventive effect via changes in maternal immune regulation supplementation with lactobacillus reuteri and 3 fatty acids started at gestational week 20 and throughout pregnancy after 20 weeks of supplementation some immunomodulatory effects among circulating activated regulatory t cells and a subpopulation of monocytes were noted several systemic immune modifying effects of pregnancy were observed in summary probiotics show several immunomodulatory effects in infants and pregnant women however more research is needed to better understand the effects of the probiotic supplementation to aid future identification of more efficacious allergy preventive strategies

Technological Tools for Predicting Pregnancy Complications 2017-10-26 background more than half of pregnant women use at least one prescribed medication during pregnancy and almost all pregnant women use some kind of over the counter medication depression is one of the most common diseases in the world today also during the peripartum period the prevalence of pregnant women using antidepressant medication is increasing general knowledge about the use of medication during pregnancy needs to improve the overall aim of the studies on which this thesis is based is therefore to examine different aspects of medication use during pregnancy with a focus on antidepressants material and methods study i was a questionnaire study where 850 pregnant women were asked about their perceptions on medication use during pregnancy in study ii plasma samples from 200 women were obtained at gestational weeks 10 12 and 25 and screened for drugs the results of the analysis were compared with medication use noted in antenatal medical care records study iii was a national register based cohort study including 262 329 pregnant women and their first child born in 2012 2015 maternal obstetric and neonatal outcomes were studied in three groups women diagnosed with depression and who had redeemed an antidepressant before becoming pregnant and women who were diagnosed with depression and who had redeemed an antidepressant both before and during pregnancy were compared with each other and with women who had neither been diagnosed with depression nor been prescribed antidepressants study iv was a pharmacokinetic study that included 81 pregnant women with ongoing antidepressant medical treatment antidepressant drug and metabolite concentrations were measured throughout pregnancy participants were genotyped for enzymes involved in antidepressant drug metabolism i e cyp2d6 and cyp2c19 results and conclusions the majority of pregnant women in our study considered the use of medication during pregnancy as either probably harmful or harmful and this perception was associated with non use of medication the women had high confidence in health care professionals when seeking advice about medication there was a good coherence between reported drug intake in antenatal care records and presence of the drug in the pregnant women s blood for drugs prescribed for continuous use the coherence was 100 thus the reported use of medication in antenatal records is reliable women with major depressive disorder and antidepressant medication prior to becoming pregnant were at

increased risk for adverse obstetric and neonatal outcomes compared with women without major depressive disorder continuation of antidepressant medication during pregnancy somewhat increased the risk of adverse obstetric and neonatal outcomes the dose adjusted concentrations of sertraline and citalopram and their metabolites did not change significantly throughout pregnancy observed concentrations of escitalopram mirtazapine and venlafaxine did not appear to change
