section 16 of the exchange act applies to an sec reporting company s directors and officers as well as shareholders who own more than 10 of a class of the company s equity securities registered under the exchange act

a person is subject to section 16 solely by being a member of a group as described in section 13 d 3 and rule 13d 5 b thereunder that beneficially owns more than 10 percent of such a class of equity security

under section 16 a requires certain insiders to report his or her initial ownership of the company s equity securities on form 3 after an initial triggering event section 16 insiders must report any changes to the amount of securities subsequently owned on form 4
