IT HAS LONG BEEN THOUGHT THAT SCIENCE IS OUR BEST HOPE FOR REALIZING OBJECTIVE KNOWLEDGE BUT THAT TO DELIVER ON THIS PROMISE IT MUST BE VALUE FREE THINGS ARE NOT SO SIMPLE HOWEVER AS RECENT WORK IN SCIENCE STUDIES MAKES CLEAR THE CONTRIBUTORS TO THIS VOLUME INVESTIGATE WHERE AND HOW VALUES ARE INVOLVED IN SCIENCE AND EXAMINE THE IMPLICATIONS OF THIS INVOLVEMENT FOR IDEALS OF OBJECTIVITY THE ROLE OF SCIENCE IN POLICYMAKING HAS GAINED UNPRECEDENTED STATURE IN THE UNITED STATES RAISING QUESTIONS ABOUT THE PLACE OF SCIENCE AND SCIENTIFIC EXPERTISE IN THE DEMOCRATIC PROCESS SOME SCIENTISTS HAVE BEEN GIVEN CONSIDERABLE EPISTEMIC AUTHORITY IN SHAPING POLICY ON ISSUES OF GREAT MORAL AND CULTURAL SIGNIFICANCE AND THE POLITICIZING OF THESE ISSUES HAS BECOME HIGHLY CONTENTIOUS SINCE WORLD WAR II MOST PHILOSOPHERS OF SCIENCE HAVE PURPORTED THE CONCEPT THAT SCIENCE SHOULD BE VALUE FREE IN SCIENCE POLICY AND THE VALUE FREE IDEAL HEATHER E DOUGLAS ARGUES THAT SUCH AN IDEAL IS NEITHER ADEQUATE NOR DESIRABLE FOR SCIENCE SHE CONTENTS THAT THE MORAL RESPONSIBILITIES OF SCIENTISTS REQUIRE THE CONSIDERATION OF VALUES EVEN AT THE HEART OF SCIENCE SHE LOBBIES FOR A NEW IDEAL IN WHICH VALUES SERVE AN ESSENTIAL FUNCTION THROUGHOUT SCIENTIFIC INQUIRY BUT WHERE THE ROLE VALUES PLAY IS CONSTRAINED AT KEY POINTS THUS PROTECTING THE INTEGRITY AND OBJECTIVITY OF SCIENCE IN THIS VEIN DOUGLAS OUTLINES A SYSTEM FOR THE APPLICATION OF VALUES TO GUIDE SCIENTISTS THROUGH POINTS OF UNCERTAINTY FRAUGHT WITH MORAL VALENCE FOLLOWING A PHILOSOPHICAL ANALYSIS OF THE HISTORICAL BACKGROUND OF SCIENCE ADVISING AND THE VALUE FREE IDEAL DOUGLAS DEFINES HOW VALUES SHOULD AND SHOULD NOT FUNCTION IN SCIENCE SHE DISCUSSES THE DISTINCTIVE DIRECT AND INDIRECT ROLES FOR VALUES IN REASONING AND OUTLINES SEVEN SENSES OF OBJECTIVITY SHOWING HOW EACH CAN BE EMPLOYED TO DETERMINE THE RELIABILITY OF SCIENTIFIC CLAIMS DOUGLAS THEN USES THESE PHILOSOPHICAL INSIGHTS TO CLARIFY THE DISTINCTION BETWEEN JUNK SCIENCE AND SOUND SCIENCE TO BE USED IN POLICYMAKING IN CONCLUSION SHE CALLS FOR GREATER OPENNESS ON THE VALUES UTILIZED IN POLICYMAKING AND MORE PUBLIC PARTICIPATION IN THE POLICYMAKING PROCESS BY SUGGESTING VARIOUS MODELS FOR EFFECTIVE USE OF BOTH THE PUBLIC AND EXPERTS IN KEY RISK ASSESSMENTS THE ROUTLEDGE COMPANION TO PHILOSOPHY OF MEDICINE IS A COMPREHENSIVE GUIDE TO TOPICS IN THE FIELDS OF EPISTEMOLOGY AND METAPHYSICS OF MEDICINE IT EXAMINES TRADITIONAL TOPICS SUCH AS THE CONCEPT OF DISEASE CAUSALITY IN MEDICINE THE EPISTEMOLOGY OF THE RANDOMIZED CONTROLLED TRIAL THE BIOPSYCHOSOCIAL MODEL EXPLANATION CLINICAL JUDGMENT AND PHENOMENOLOGY OF MEDICINE AND EMERGING TOPICS SUCH AS PHILOSOPHY OF EPIDEMIOLOGY MEASURING HARMS THE CONCEPT OF DISABILITY NURSING PERSPECTIVES RACE AND GENDER THE METAPHYSICS OF CHINESE MEDICINE AND NARRATIVE MEDICINE EACH OF THE 48 CHAPTERS IS WRITTEN ESPECIALLY FOR THIS VOLUME AND WITH A STUDENT AUDIENCE IN MIND FOR PEDAGOGY AND CLARITY EACH CHAPTER CONTAINS AN EXTENDED EXAMPLE ILLUSTRATING THE IDEAS DISCUSSED THIS TEXT IS INTENDED FOR USE AS A REFERENCE FOR STUDENTS IN COURSES IN PHILOSOPHY OF MEDICINE AND PHILOSOPHY OF SCIENCE AND PAIRS WELL MORALITY THIS BOOK HAS THE ROLE OF IDEALS AS ITS CENTRAL THEME MORE SPECIFICALLY IT ARGUES THAT IDEALS ARE NECESSARY TO UNDERSTAND PLURALISM THAT THEY ARE KEY ELEMENTS IN CONTROVERSY AND DEBATE AND THAT THEY ENABLE DEVELOPMENT IT COMBINES THEORETICAL ANALYSIS OF THE CONCEPT OF IDEALS WITH DISCUSSION OF CONCRETE DEBATES AND CASES INCLUDING PHILOSOPHICAL DEBATES ABOUT POLITICS AND EQUALITY SOCIOLOGICAL STUDIES OF THE DIVERSE INTERPRETATIONS OF THE RULE OF LAW AND ACCOUNTS OF THE DEVELOPMENT OF ENVIRONMENTAL LAW AND PRIVACY LAW THUS THE FUNCTIONING OF IDEALS IS CRITICALLY EXAMINED SHOWING THE MERITS AND LIMITATIONS OF AN IDEAL ORIENTED APPROACH THE FIRST REFERENCE ON RATIONALITY THAT INTEGRATES ACCOUNTS FROM PSYCHOLOGY AND PHILOSOPHY COVERING DESCRIPTIVE AND NORMATIVE THEORIES FROM BOTH DISCIPLINES BOTH ANALYTIC PHILOSOPHY AND COGNITIVE PSYCHOLOGY HAVE MADE DRAMATIC ADVANCES IN UNDERSTANDING RATIONALITY BUT THERE HAS BEEN LITTLE INTERACTION BETWEEN THE DISCIPLINES THIS VOLUME OFFERS THE FIRST INTEGRATED OVERVIEW OF THE STATE OF THE ART IN THE PSYCHOLOGY AND PHILOSOPHY OF RATIONALITY WRITTEN BY LEADING EXPERTS FROM BOTH DISCIPLINES THE HANDBOOK OF RATIONALITY COVERS THE MAIN NORMATIVE AND DESCRIPTIVE THEORIES OF RATIONALITY HOW PEOPLE OUGHT TO THINK HOW THEY ACTUALLY THINK AND WHY WE OFTEN DEVIATE FROM WHAT WE CAN CALL RATIONAL IT ALSO OFFERS INSIGHTS FROM OTHER FIELDS SUCH AS ARTIFICIAL INTELLIGENCE ECONOMICS THE SOCIAL SCIENCES AND COGNITIVE NEUROSCIENCE THE HANDBOOK PROPOSES A NOVEL CLASSIFICATION SYSTEM FOR RESEARCHERS IN HUMAN RATIONALITY AND IT CREATES NEW CONNECTIONS BETWEEN RATIONALITY RESEARCH IN PHILOSOPHY PSYCHOLOGY AND OTHER DISCIPLINES FOLLOWING THE BASIC DISTINCTION BETWEEN THEORETICAL AND PRACTICAL RATIONALITY THE BOOK FIRST CONSIDERS THE THEORETICAL SIDE INCLUDING NORMATIVE AND DESCRIPTIVE THEORIES OF LOGICAL PROBABILISTIC CAUSAL AND DEFEASIBLE REASONING IT THEN TURNS TO THE PRACTICAL SIDE DISCUSSING TOPICS SUCH AS DECISION MAKING BOUNDED RATIONALITY GAME THEORY DEONTIC AND LEGAL REASONING AND THE RELATION BETWEEN RATIONALITY AND MORALITY FINALLY IT COVERS TOPICS THAT ARISE IN BOTH THEORETICAL AND PRACTICAL RATIONALITY INCLUDING VISUAL AND SPATIAL THINKING SCIENTIFIC RATIONALITY HOW CHILDREN LEARN TO REASON RATIONALLY AND THE CONNECTION BETWEEN INTELLIGENCE AND RATIONALITY RECENT DECADES HAVE SEEN ATTACKS ON PHILOSOPHY AS AN IRRELEVANT FIELD OF INQUIRY WHEN COMPARED WITH SCIENCE IN THIS BOOK GRAHAM MCFEE DEFENDS THE CLAIMS OF PHILOSOPHY AGAINST ATTEMPTS TO MINIMIZE EITHER PHILOSOPHY S POSSIBILITY OR ITS IMPORTANCE BY DEPLOYING A CONTRAST WITH WHAT WITTGENSTEIN CHARACTERIZED AS THE DAZZLING IDEAL OF SCIENCE THIS DAZZLING IDEAL INCORPORATES BOTH THE IMAGINED COMPLETENESS OF SCIENTIFIC EXPLANATION WHEREBY COMPLETING ITS PROJECT WOULD LEAVE NOTHING UNEXPLAINED AND THE EXCEPTIONLESS CHARACTER OF THE ASSOCIATED CONCEPTION OF CAUSALITY ON SUCH A SCIENTISTIC WORLD VIEW WHAT NEED IS THERE FOR PHILOSOPHY IN HIS DEFENSE OF PHILOSOPHY AND ITS TRUTH CLAIMS MCFEE SHOWS THAT REJECTING SUCH SCIENTISM IS NOT AUTOMATICALLY ANTI SCIENTIFIC AND THAT IT PERMITS GRANTING TO NATURAL SCIENCE PROPERLY UNDERSTOOD ITS OWN TRUTH GENERATING POWER FURTHER MCFEE ARGUES FOR CONTEXTUALISM IN THE PROJECT OF PHILOSOPHY AND SETS ASIDE THE PERVASIVE AND PERNICIOUS REQUIREMENT FOR EXCEPTIONLESS GENERALIZATIONS WHILE RELATING HIS ACCOUNT TO INTERCONNECTIONS BETWEEN THE CONCEPTS OF PERSON SUBSTANCE AGENCY AND CAUSATION JOSEPH BEN DAVID DIED TWENTY FIVE YEARS AGO IN JANUARY 1986 AN EMINENT SOCIOLOGIST OF SCIENCE AND A CO FOUNDER OF THIS SUB DISCIPLINE HE WAS ONLY SIXTY FIVE YEARS OLD FEW SOCIAL SCIENTISTS ARE REMEMBERED AFTER THEY DIE AND CAN NO LONGER PARLAY THEIR INFLUENCE INTO THE GOODS OF THIS WORLD FOR COLLEAGUES AND ACQUAINTANCES THIS WAS NOT BEN DAVID S FATE HIS WORK CONTINUES TO BE TAUGHT AND REFERRED TO BY SCHOLARS SPREAD FAR AND WIDE IN TERMS OF BOTH COUNTRIES AND DISCIPLINES HIS STUDENTS NEVER FORGOT HIM HIS BOOKS WERE REPUBLISHED AND HIS ESSAYS APPEARED IN NEW COLLECTIONS BEN DAVID S LEGACY INCLUDES IDEAS AND IDEALS ITS CENTRAL TENET IS THE AUTONOMY OF SCIENCE ITS RIGHT AND DUTY TO BE VALUE FREE SCHOLARSHIP ORIENTED TO

ANY GOAL OTHER THAN THE ACCUMULATION OF OBJECTIVE KNOWLEDGE ABOUT EMPIRICAL REALITY FOR HIM WAS SCIENCE NO LONGER AND DID NOT HAVE ITS AUTHORITY IN THIS LIGHT THE LIFE OF SCHOLARSHIP WAS ONE OF MORAL DEDICATION WITH NOTHING LESS THAN THE FATE OF LIBERAL DEMOCRATIC SOCIETY DEPENDING ON IT AND FOR SCIENCE TO THRIVE THE UNIVERSITY ITS HOME HAD TO BE THE EMBODIMENT OF THE CARDINAL VIRTUE OF THIS SOCIETY THE VIRTUE OF CIVILITY IN THE SPIRIT OF BEN DAVID BELIEVING THAT SCHOLARLY DEBATE ADVANCES COMMON GOOD AND RATIONAL DISCOURSE WINS WHICHEVER WAY ARGUMENTS IN IT ARE SETTLED THIS FESTSCHRIFT DEBATES SUCH CORE ISSUES AS THE NATURE OF SCIENCE ITS CHANGING DEFINITION AND POSITION IN WESTERN SOCIETY THE FORMS OF ORGANIZATION OPTIMAL FOR SCIENTIFIC CREATIVITY AND THE ABILITY OF THE RESEARCH UNIVERSITY TO FOSTER SCIENTIFIC GROWTH WHILE ALSO PERFORMING ITS EDUCATIONAL ROLE THIS HANDBOOK IS CURRENTLY IN DEVELOPMENT WITH INDIVIDUAL ARTICLES PUBLISHING ONLINE IN ADVANCE OF PRINT PUBLICATION CAREER INTERESTS OF THE SCIENTISTS INVOLVED FOR INSTANCE THE PHARMACEUTICAL GIANT MERCK MANIPULATED CLINICAL TRIAL DATA IN ORDER TO MAKE SURE THAT DATA CONFIRMED THE SAFETY OF ONE OF ITS PRODUCTS VIOXX IN ORDER TO SERVE THE COMPANY S SHORT TERM COMMERCIAL INTERESTS THIS CASE IS OBVIOUSLY UNACCEPTABLE BUT WHY EXACTLY IS IT UNACCEPTABLE ONE WAY TO ACCOUNT FOR THIS JUDGMENT IS ON THE BASIS OF THE IDEAL OF PURITY ACCORDING TO THIS IDEAL SCIENTIFIC DECISION MAKING SHOULD BE PURE THAT IS UNAFFECTED BY FINANCIAL INTERESTS POLITICAL INTERESTS CAREER INTERESTS AND SO ON ALTHOUGH THIS IDEAL IS QUESTIONABLE MANY PEOPLE INCLUDING PHILOSOPHERS OF SCIENCE STILL HOLD ON TO IT IN INTERESTS AND EPISTEMIC INTEGRITY IN SCIENCE A NEW FRAMEWORK TO ASSESS INTEREST INFLUENCES IN SCIENTIFIC RESEARCH PROCESSES JAN DE WINTER FIRST ARGUES THAT IT IS BETTER TO FULLY ABANDON THE IDEAL OF PURITY THEN PROPOSES AN ALTERNATIVE IDEAL TO ASSESS INTEREST INFLUENCES IN SCIENCE THE IDEAL OF EPISTEMIC INTEGRITY HE SPELLS OUT AND SYSTEMATICALLY DEFENDS A NEW CONCEPT OF EPISTEMIC INTEGRITY USING IT NOT ONLY TO ANALYZE THE VIOXX DEBACLE BUT ALSO TO IDENTIFY UNACCEPTABLE INTEREST INFLUENCES IN AEROSPACE SCIENCE CLIMATE SCIENCE AND BIOLOGY AND TO EXPLAIN EXACTLY WHY THESE INTEREST INFLUENCES ARE UNACCEPTABLE THESE ANALYSES MAKE A COMPELLING CASE FOR THE NEW CONCEPT OF EPISTEMIC INTEGRITY WHICH WILL BE INTERESTING AND USEFUL FOR PHILOSOPHERS OF SCIENCE SCIENTISTS ENGINEERS SCIENCE POLICYMAKERS AND ANYONE ELSE CONCERNED ABOUT THE INTEGRITY OF SCIENCE DESCARTES ONCE ARGUED THAT WITH SUFFICIENT EFFORT AND SKILL A SINGLE SCIENTIST COULD UNCOVER FUNDAMENTAL TRUTHS ABOUT OUR WORLD CONTEMPORARY SCIENCE PROVES THE LIMITS OF THIS CLAIM FROM SYNTHESIZING THE HUMAN GENOME TO PREDICTING THE EFFECTS OF CLIMATE CHANGE SOME CURRENT SCIENTIFIC RESEARCH REQUIRES THE COLLABORATION OF HUNDREDS IF NOT THOUSANDS OF SCIENTISTS WITH VARIOUS SPECIALIZATIONS ADDITIONALLY THE MAJORITY OF PUBLISHED SCIENTIFIC RESEARCH IS NOW CO AUTHORED INCLUDING MORE THAN 80 OF ARTICLES IN THE NATURAL SCIENCES MEANING SMALL COLLABORATIVE TEAMS HAVE BECOME THE NORM IN SCIENCE THIS VOLUME IS THE FIRST TO ADDRESS CRITICAL PHILOSOPHICAL QUESTIONS REGARDING HOW COLLECTIVE SCIENTIFIC RESEARCH COULD BE ORGANIZED DIFFERENTLY AND HOW IT SHOULD BE ORGANIZED FOR EXAMPLE SHOULD SCIENTISTS BE REQUIRED TO SHARE KNOWLEDGE WITH
