of the code into positive law when a title is enacted into positive law the underlying statutes are repealed and the title then becomes legal evidence of the law currently 26 of the 51 titles in the code have been so enacted these are identified in the table of titles near the beginning of each volume the law revision counsel of the house of representatives continues to prepare legislation pursuant to 2 u s c 285b to enact the remainder of the code on a title by title basis into positive law the 2012 edition of the code was prepared and published under the supervision of ralph v seep law revision counsel grateful acknowledgment is made of the contributions by all who helped in this work particularly the staffs of the office of the law revision counsel and the government printing office preface
