this book offers a meso level description of demographics science education and science teacher education representing all 13 canadian jurisdictions the book provides local insights that serve as the basis for exploring the canadian system as a whole and function as a common starting point from which to identify causal relationships that may be associated with canada s successes the book highlights commonalities consistencies and distinctions across the provinces and territories in a thematic analysis of the 13 jurisdiction specific chapters although the analysis indicates a network of policy and practice issues warranting further consideration the diverse nature of canadian science education makes simple identification of causal relationships elusive canada has a reputation for strong science achievement however there is currently limited literature on science education in canada at the general level or in specific areas such as canadian science curriculum or science teacher education this book fills that gap by presenting a thorough description of science education at the provincial territorial level as well as a more holistic description of pressing issues for canadian science education

in canada today there is a clear move toward a more outcomes based education system this report examines the state of high school student assessment and reviews standards and accountability strategies it reports on the policies programs and initiatives in all provincial ministries or departments of education and a sample of school boards across the country data were derived from a telephone survey of departmental ministerial representatives from all 10 provinces and the 2 territories and from a questionnaire that was mailed to 279 school boards a total of 140 boards responded a 50 percent response rate data show that both boards and ministries are putting more emphasis on the development of comprehensive policies to cover all aspects of student evaluation there is some movement away from relying on paper and pencil testing as the sole means of evaluation the use of more authentic performance based approaches and a greater variety of assessment techniques are being promoted some of the best practices in high school evaluation involve use of a broad range of assessment methods introduction of or improvements to provincial examinations greater use of summative and formative evaluations greater emphasis on modifying evaluation for special needs students use of performance based assessment and more reporting to parents and the public thirteen tables are included appendices contain copies of the two questionnaires and selected school board material contains 19 references lmi

over the last decade or two there has been increasing consensus that academic research if used judiciously to guide practice improves both educational policy and pedagogy

ultimately leading to better outcomes for students yet despite this potential there remains a deep ravine between the body of knowledge built through research especially at the intersection between specific interventions and improved student achievement and the actions taken by policy makers administrators and classroom teachers in their regular practice there are myriad reasons for this research practice divide among them is that it is difficult for district based people to access primary research furthermore multiple waves of well intentioned research based but largely unsuccessful school reform efforts have resulted in skepticism among practitioners about research and at the same time damaged researchers credibility in the field this book is divided into three broad areas first it develops an engaging analysis of the root causes for the research practice gap in education second it describes the framework developed and used in a public school district by the author to address the root causes and provides evidence of its efficacy to facilitate greater incorporation of research into school and district level practice through a process the author calls knowledge cultivation the framework uses weekly research summaries for district leaders that are relevant to their real time issues along with suggestions about ways in which the research might be useful the final section of the book includes the actual research summaries used by the author over a five year period

are the learning needs of children and youth being met by the canadian school system is it possible for all students to learn what is essential to function in our society what must be done to reform schools canadian parents business leaders citizens community and political leaders are asking these and similar questions they know that education is essential for their children and they realize that our country s future depends on a population of educated citizens this book is bill mckerlich s response to these questions twelve steps to reform canadian public education outlines both a comprehensive assessment and a thoughtful plan for the necessary reform of our schools written by an experienced educator focus to adjust the focal length of the eye to give a clear image our school system may have been adequate for the past but is now out of focus with the present learning needs of our students the system requires immediate adjustment so that it has a clear image of purpose and how to achieve this purpose as part of this process it will be necessary to improve the early childhood development of an important minority of our children using our democratic processes these adjustments will be discussed and changes decided the results will be immediately planned and implemented if this does not happen effective public schooling for all children and youth will be lost and a significant minority of canadian children will not reach their potential to be happy and productive citizens the resulting long term negative social and economic consequences will cripple our society book purpose the purpose of this book is to assist this important public discussion by outlining a plan of school reform in twelve steps the plan describes how the early childhood development of some deprived children can improve and how the school system can be refocused so that all children will learn to the maximum of their ability book organisation the steps are stated at the beginning of the chapters in which they are described the first five chapters centre on children learning teaching and schools the later four chapters describe the organisation governance leadership and management processes required for schools to have all children learn the twelve steps form a planned approach to improving schools with the steps often interdependent on each other this approach is in contrast to the unsatisfactory ad hoc tinkering that public education has experienced over the years the plan has direct relevance to the canadian provinces but may have some application to the education jurisdictions of other countries visit the author s website at reform education com

in her portrayal of the life of sister catherine donnelly founder of the sisters of service author jeanne beck has succeeded in weaving a tapestry rich in texture broad in scope and deeply revealing of the character of a memorable canadian woman brian f hogan c s b when teacher catherine donnelly first arrived in western canada from ontario in 1918 she discovered two things first the need for a catholic presence in the rural public schools of the west and second her own calling to be a religious catherine saw that the west was growing rapidly and that there was a lack of religious guidance for the people of the region particularly the immigrants coming from other countries she looked to existing catholic orders as a means of reaching these people but found that none of the orders were willing to accept catherine's radical ideas such as her refusal to wear the traditional nun's habit and her strong belief in the individuality of members of orders catherine founded the sisters of service in 1922 and through this new order was able to make an impact on the lives of townspeople and students in prairie schools of the west in this biography jeanne beck reconstructs the extraordinary life of sister catherine donnelly the well researched account is at once informative and inspiring a fitting tribute to the woman who believed the spiritual life and the intellectual life have the same root deep in the unity of the intelligence

this book is for teachers teacher educators school and district administrators policy makers and researchers who want to know about literacy cultural diversity and students who speak little or no english it offers a rich picture of the incredible diversity of students who enter secondary school as immigrants their abilities their needs and their aspirations the studies reported are part of a large longitudinal study of about 25 000 immigrant students in a district in which the policy is english only instruction these studies provide multiple views of the students lives and their success in schools where the language of instruction differs from the languages they speak with their friends and families explore the students views of teaching and learning describe the potential differences between the students views and those of their teachers look at issues related to students views of their identities as they work study and socialize in a new environment and examine different reading models designed to facilitate the learning of english as a second language esl educators and researchers will find the descriptions of students simultaneous learning of english and of academic content relevant to their view of whether instruction should be english only or bilingual for teachers who view multicultural education as an important endeavor this book may on occasion surprise them and at other times confirm their views the author does not attempt to develop a particular political viewpoint about which approach works best with immigrant students rather the objective of the studies was to develop a full rich description of the lives of immigrant high school students enrolled in classes where the medium of instruction is english the reader is left to evaluate the results

in the early 1960s a group of students at ubc started a magazine called tish the name was purposefully an anagram of shit in order to demonstrate their youthful and iconoclastic attitude in many ways tish and its editors became the clear break from older canadian poets and styles at the heart of the magazine and the movement was frank davey and it is davey who has written this definitive history davey has organized the material as a memoir starting from his own early days in abbotsford b c and gradually introducing the other poets including george bowring daphne marlatt and fred wah despite the fact that davey doesn't meet them until they all arrive at ubc much of the theory of the tish poets derives from the black mountain poets an american movement that incorporated the writings of charles olson robert creeley and robert duncan who suggested the name itself the black mountain poets believed that writing should be locally based and should grow out of t
